PUBLICATION OF DRAFT ASSESSMENT / RE-ASSESSMENT LIST WITH NEW RATE UNDER 'HAILAKANDI MUNICIPAL AREA'

In accordance to the Govt. Notification No. UDD(M)136/22/17, dated 28-06-2022, DMA.162/2022/71, dated 05-09-2022 and E-250185/1, dated 06-02-2023, the holding tax of Hailakandi Town has been re-assessed and the New re-assessed holding / property tax will be effective from 1st April' 2023 under Hailakandi Municipal area as per new rates stated below. The new rates shall remain valid for a period of 5 (five) years, i.e., till 31st March' 2028. Therefore, the draft is hereby prepared in accordance with the Assam Municipal Act' 1956 u/s 79F and a copy thereof is available for inspection at the office of the Hailakandi Municipal Board during office hours.

The citizens can submit their claims and object, if any w.e.f. 20-02-2023 to 20-03-2023 (one month period) as provided u/s 83 of the Assam Municipal Act' 1956. The claims shall be heard by the undersigned officers of the Board during office hours. The final assessment list shall be sent to the Govt. for review as provided u/s 79E of the act.

Assessment of Property Tax is carried out by adopting property tax formula ARV (Unit Area Method).

- 1) Annual Rental Value (ARV) is considered as 7.50% of value of the property.
- 2) For Residential/Flat/Religious institute building, maximum 15% rebate/discount will be provided.
- 3) For commercial building, there is no rebate/discount.
- 4) For Assam Type building, DSR-2021 (1.2.2 Framed structure) is considered
- 5) For RCC Building, DSR-2021 (1.1.1, 1.1.2 + 1.3.2) is considered.
- 6) For other type / Katcha house, Hailakandi MB fixed the rate of construction as stated hereunder.
- 7) The details of the land value (Table 1) and structural value & Rate of Taxes (Table 2) is given below.
- 8) Depreciation shall be allowed @0.5% of the value of building on all type of structure per year upto max. 45 years till 2022.
